1. Introduction

This Privacy Policy sets out the Agreement between users of the Conduce Website (Website) and Conduce Group Limited (We), the owner and provider of this Website. We take the privacy of your information very seriously. This Privacy Policy applies to any and all data collected by us or provided by you concerning your Website use.

This Privacy Policy should be read alongside, and in addition to, our Terms and Conditions, which can be found on the Website.

2. Scope of this Privacy Policy

This Privacy Policy applies only to the actions of Conduce Group Limited and Users concerning this Website. It does not extend to any websites that can be accessed from this Website, including, but not limited to, any links we may provide to social media websites.

For purposes of the applicable data protection laws, we are the "data controller". This means that We determine the purposes for which and the manner in which your Data is processed.

3. What Data Do We Collect?

We may collect the following data, which may include personal data, from you:

- Email addresses
- IP address

4. How Do We Collect Data?

We collect data in the following ways:

- You provide us with data when you access any of the videos we have uploaded to the Website.
- We automatically collect some information about your visit to the Website, including your IP address, the date, times, and frequency with which you access the Website and how you use and interact with its content.

We will collect your Data automatically via cookies, in line with the cookie settings on your browser. See the Cookies section below for more information about cookies and how we use them on the Website.

Henceforth this Data will be collectively referred to as "the Data".

5. How Do We Use Data?

We may use any or all of the Data at our discretion to run analytics on the Website's functionality. This will help us improve and refine our Website's content, design, and layout and ensure that the Website's content is presented most effectively for you and your computer.

We do not use your data for marketing, microtargeting, or advertising purposes, means, or activities. We do not use profiling or automated decision-making processes.

6. Data Sharing

Like many businesses, we use Google Analytics tools to analyse our web traffic. Additionally, articles on the Website may include embedded content (e.g. videos, images, articles, etc.) from other websites. This content behaves exactly as if the visitor were visiting such other websites.

7. Data Security

We store Data on secure servers in the UK. We have technical and organisational measures to respond to any suspected data breach. If you suspect any misuse, loss, or unauthorised access to your Data, please let us know immediately via info@conduce.net.

We will not share, sell, or distribute any of the information you provide to us without your consent, except where the law requires disclosure.

8. Data Storage

Unless a more extended retention period is required or permitted by law, we will only retain your Data for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.

Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

9. What Are Your Data Protection Rights?

You have the following rights:

- Right to access - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update, or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this unless your request is "manifestly

unfounded or excessive." We may refuse your request where we are legally permitted to do so. If we reject your request, we will tell you the reasons why.

- Right to correct - the right to have your Data rectified if it is inaccurate or incomplete.
- Right to erase - the right to request that we delete or remove your Data from our systems.
- Right to restrict our use of your Data - the right to "block" us from using it or limit how we can use it.
- Right to data portability - the right to request that we move, copy, or transfer your Data.
- Right to object - the right to object to your data use, including where we use it for our legitimate interests.

10. Cookies

A cookie is a small text file that a website stores on your computer or mobile device, storing information about your visit.

11. How Do We Use Cookies?

This means that the main cookie banner can be minimised on future visits and that analytics and advertising cookies are not set for visitors who opt out of this tracking.
Third-party cookies	Google Analytics	Google Analytics is a web analytics service provided by Google, Inc. to help us see how our Website is used. In doing so, information about your use of our Website, including your IP address, may be transmitted to Google and stored on its relevant servers. The data collected is used to analyse how frequently people revisit the Website, and the Website is found. This information is combined with data from thousands of other users to create an overall picture of website use and is never identified individually or personally, and is not linked to any additional information we store about you.
